6. Students in selected undergraduate programmes may choose to take Master-level modules as electives.  
These modules are part of the Integrated Bachelor-Master Programme (IBMP) pathway and will be charged according to the postgraduate credit hour fee.

7. The enrolment fee is strictly non-refundable except in the event student cannot be accepted due to non-fulfilment of minimum entry requirements (this does not include provisional/ conditional offer).  
An administrative fee will be charged for semester fee refunds resulting from voluntary withdrawal prior to the commencement of the semester.

Any shortfall resulting from foreign exchange fluctuations or bank charges will be the responsibility of the student. Conversely, any surplus will be recorded as an excess payment.
